• August 3 <sup>rd</sup> , 2022	Approval of the Semi-annual Report as of June 30th, 2022
• November 10 <sup>th</sup> , 2022	Approval of the Interim Report as of September 30 <sup>th</sup> , 2022

Conference calls with investors and financial analysts will be held after the Board of Directors meetings scheduled for February, May, August, and November. Any change to the abovementioned dates will be timely communicated to the market.

It should also be noted that the Company's Capital Markets Day will be held on January 26th, 2022.
