Completato il riacquisto di 600.000 azioni proprie al prezzo medio di Euro 20,56 per un controvalore complessivo di 12,3 milioni di Euro

Forlì, 12 gennaio 2022 – Unieuro S.p.A. (Euronext STAR Milan: UNIR), il leader nella distribuzione di elettronica di consumo ed elettrodomestici in Italia, comunica di aver completato il programma di acquisto di azioni proprie (il “**Programma**”), il cui avvio è stato deliberato dal Consiglio di Amministrazione in data 11 novembre 2021, in parziale esecuzione della delibera dall’Assemblea ordinaria degli Azionisti di Unieuro S.p.A. del 17 dicembre 2020.

In particolare, la Società informa di avere acquistato, nel periodo compreso fra il 10 gennaio e l’11 gennaio 2022, n. 40.000 azioni ordinarie proprie, corrispondenti allo 0,1932% del capitale sociale, per un controvalore complessivo – commissioni escluse – di Euro 788.447,50.
