Tortona, 19 January 2022. Group ASTM announces that the Concession Contract for the management of the motorway link composed by the stretches A12 Sestri Levante-Livorno, A11/A12 Viareggio-Lucca, A15 La Spezia junction and A10 Savona-Ventimiglia (French border) was signed with the Ministry of Sustainable Infrastructures and Mobility (MIMS).

In November 2020, the MIMS awarded the abovementioned tender to Itinera S.p.A., a member of the ASTM Group, based on the best technical and economic score, which further confirms the competences acquired by the Group in the realization and management of complex infrastructure assets.

The new concession will have a duration of 11 years and 6 months from the date of takeover.

ASTM Group is the second largest operator in the world in the management of motorway infrastructures with a network of approximately 4,900 km of network, of which more than 1,400 km in Italy, around 3,400 km in Brazil through the listed company EcoRodovias and 84 km in the United Kingdom through participation in Road Link. Present in over 15 countries and with approximately 15,000 employees and collaborators, the Group's activities are focused on three main areas: management of motorway infrastructures (concessions), design and construction of major works (EPC - Engineering, Procurement and Construction) and technology applied to transport mobility.
