UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, January 24^{th} , $202I - In relation to the share buyback program resolved by the Shareholders' Meeting of April <math>23^{rd}$, 202I, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period $19^{th} - 21^{st}$ January, 2022, a total of 120,000 ordinary Amplifon S.p.A. shares, equivalent to 0.053% of the share capital, at an average unit price of Euro 39.873 per share, for a total consideration of Euro 4,784,739.60.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 20II-2020 and Performance Stock Grant Plan 20I4-2021 for a total of n. I3,745,340 shares.

As of January 2st, 2022, Amplifon owned n. I,520,460 of its shares, corresponding to 0.672% of the Company's share capital and to 0.471% of the total share capital in voting rights.
