UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, February 7th, 2022 – In relation to the share buyback program resolved by the Shareholders' Meeting of April 23rd, 2021, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period January 31st – February 4th, 2022, a total of 200,000 ordinary Amplifon S.p.A. shares, equivalent to 0.088% of the share capital, at an average unit price of Euro 37.831 per share, for a total consideration of Euro 7,566,116.80.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 and Performance Stock Grant Plan 2014-2021 for a total of n. 13,749,540 shares.

As of January 28th, 2022, Amplifon owned n. 1,916,260 of its shares, corresponding to 0.846% of the Company's share capital and to 0.593% of the total share capital in voting rights.
