#### WEEKLY DISCLOSURE ON THE BUY-BACK PROGRAMME OF ITALIAN WINE BRANDS S.P.A.

**Milan, February 14<sup>th</sup>, 2022** - With regard to the share buy-back programme, the launch of which was announced on December 3<sup>rd</sup>, 2021, Italian Wine Brands S.p.A. (“**IWB**”) announces that in the period between February 7<sup>th</sup>, 2022 and February 11<sup>th</sup>, 2022 it purchased No. 4,341 treasury shares for a total countervalue of Euro 117,624.30, pursuant to the authorisation resolved by the Shareholders’ Meeting held on April 22<sup>nd</sup>, 2021.
