FinecoBank: Conclusion of Treasury Shares Purchase Programme servicing the 2021 incentive system for Financial Advisors - "2021 PFA System"*

Milan, March 10th, 2022

On March 10th 2022, FinecoBank concluded the Treasury Shares purchase programme to service the 2021 incentive system "2021 PFA System", initiated on February 10th 2022 and already disclosed to the market also pursuant to art. 144-bis of Consob Issuers Regulation adopted with resolution n. 11971/1999, with reference to the press release issued on February 9th 2022, to which reference is made.

FinecoBank wishes to inform that on March 7th, 2022 it purchased on the Euronext Milan, n. 34,800 ordinary Fineco shares, equal to 0.0057% of share capital, at the average price of 12.82 Euro per share, for an overall value of 446,136 Euro.

Details of the transactions on a daily aggregated basis are provided below. Detail of each purchase is attached to this press release.

The purchase transactions were carried out in compliance with applicable legislation and regulations, as well as consistent with and within the limits indicated by the shareholders authorization and the related Board implementation resolution.

During the period of implementation of the Program considered as a whole (from February 10th to March 10th, 2022), FinecoBank purchased a total of 59,800 treasury shares, equal to 0.0098% of share capital, at an average unit price of 14.20796 Euro, for a value of 849,636 Euro.

At the date of this press release, the Bank holds 136,479 treasury shares, equal to 0.02238% of share capital.
