FRANCESCO BARDELLI NEW DIRECTOR OF CATTOLICA ASSICURAZIONI

The Board of Directors appointed the director Stefano Gentili as Vice Chairman

Verona, 22 March 2022. The Board of Directors of Cattolica Assicurazioni, which met today in Verona under the chairmanship of Davide Croff, co-opted Francesco Bardelli among its members as non-independent non-executive director. Francesco Bardelli takes over from Luigi Migliavacca, the former Vice Chairman. The Board of Directors also decided to appoint Stefano Gentili as Vice Chairman.
