**Milan, March 24, 2022**- Further to the press release of March 16, 2022 - whereby it was announced that the board of directors of WIIT S.p.A. ("WIIT" or the "Company") had approved, as per Articles 2501-ter and 2505 of the Civil Code, the merger proposal (the "**Merger Proposal**") by incorporation of Adelante S.r.l., Matika S.p.A. and Etaeria S.p.A. (jointly the "**Merging Companies**" and, together with WIIT, the "**Companies Participating in the Merger**"), into the Company - it is hereby announced that the last of the registrations of the Merger Proposal filed on March 18, 2022 with the respective Registers of Companies of the Companies Participating in the Merger took place today.

It is considered that the transaction will be completed in accordance with the simplified procedure as per Article 2505 of the Civil Code, subject to the option under Article 2505, paragraph 3, of the Civil Code.

The Merger Proposal and further documentation will be made available to the public pursuant to Article 2501-septies of the Civil Code. The merger documentation will also be published within the terms and according to the procedures provided for by law and regulations, at the registered office, on WIIT's website (<https://www.wiit.cloud/it/>) and at the authorised storage mechanism "eMarket STORAGE" ([www.emarketstorage.com](http://www.emarketstorage.com)).
