ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 22 April 2014, acquired, in the period from 30 March to 2 April 2015 included, n. 17,500 of the Company's ordinary shares (equal to 0.02% of the share capital), at an average price of € 13.1402 per share for a total amount of about € 229.95 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,433,000 own shares (5.04% of the share capital) of which n. 4,411,500 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
