## PRESS RELEASE

Turin, April 20, 2015. ASTM S.p.A. announces that:

- i. in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 22 April 2014 ('2014 Plan'), acquired, on 13 April and 14 April 2015, n. 10,500 of the Company's ordinary shares (equal to 0.012% of the share capital), at an average price of € 13.3866 per share for a total amount of about € 140.56 thousands.

- ii. in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, on 16 April and 17 April 2015, n. 27,500 of the Company's ordinary shares (equal to 0.031% of the share capital), at an average price of € 13.0318 per share for a total amount of about € 358.38 thousands.
