ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 20 April to 24 April 2015 included, n. 48,300 of the Company's ordinary shares (equal to 0.055% of the share capital), at an average price of € 12.6114 per share for a total amount of about € 609.13 thousands.
