*Turin, 29 May 2015.* ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 25 May to 29 May 2015 included, n. 12,500 of the Company's ordinary shares (equal to 0.014% of the share capital), at an average price of € 12.4352 per share for a total amount of about € 155.440 thousands.

Since the start of the share buy-back, ASTM S.p.A. acquired a total of n. 91,300 own shares (corresponding to 0.1% of the share capital) for a total amount of € 1,160.2 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,554,300 own shares (5.18% of the share capital) of which n. 4,532,800 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
