## PRESS RELEASE

*Turin, 8 June 2015.* ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 1 June to 5 June 2015 included, n. 26,200 of the Company's ordinary shares (equal to 0.03% of the share capital), at an average price of € 12.3178 per share for a total amount of about € 322.7 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,580,500 own shares (5.21% of the share capital) of which n. 4,559,000 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
