Be Think, Solve, Execute S.p.A. (**Be**) has been informed by its shareholder Data Holding 2007 S.r.l. that the shareholders of Investment Partners S.p.A., iFuture Power in Action S.r.l., Ital Benim S.r.l. and Consulgest S.r.l. (now Ingegneria e Servizi per Impianti Speciali S.r.l.) yesterday unanimously resolved upon the winding-up of the company, pursuant to art. 2484, para 1, no. 6 of the Italian Civil Code, placing it in liquidation and appointing the liquidator. This operation will complete the project of reattributing the equity investments to the individual shareholders, with a view to guaranteeing a more direct management of their investment and greater participation of the individuals in corporate life and the shared process of value.

The liquidation procedure is expected to be completed by the end of June 2015.
