## PRESS RELEASE

*Turin, 22 June 2015.* ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, on 15 June and 16 June 2015, n. 7,500 of the Company's ordinary shares (equal to 0.01% of the share capital), at an average price of € 11.4724 per share for a total amount of about € 86 thousands.

The daily detail of the operations is reported below:

Since the start of the share buy-back, ASTM S.p.A. acquired a total of n. 150,900 own shares (corresponding to 0.17% of the share capital) for a total amount of € 1,875.1 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,613,900 own shares (5.24% of the share capital) of which n. 4,592,400 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
