Siena, 3 July 2015 – Pursuant to Article 85-bis of CONSOB Regulation No. 11971/1999, following the filing with the Companies' Register of Siena, on the date hereof, of the statement pursuant to Article 2444 of the Italian Civil Code about the new share capital, Banca Monte dei Paschi di Siena S.p.A. ("**BMPS**") announces the new composition of the share capital of BMPS, following the execution of the share capital increase for Euro 243,073,800.00 in service of the payment in kind of the interests as at 31 December 2014 to be paid to the Ministry of Economy and Finance (MEF) pursuant to the regulation of the "New Financial Instruments" in accordance with Law Decree 6 July 2012, No. 95 (as amended), with the issue of 117,997,241 ordinary shares, resolved by the Board of Directors on 21 May 2015 following the resolution of the Shareholders' Meeting of BMPS held on 25 January 2013.
