ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 3 August to 7 August 2015 included, n. 40,400 of the Company's ordinary shares (equal to 0.05% of the share capital), at an average price of € 12.4154 per share for a total amount of about € 501.6 thousands.
