AMPLIFON ACQUIRES THIRTY STORES IN GERMANY

WITH THE ACQUISITION ANNOUNCED TODAY, THE LEADING GROUP IN HEARING SOLUTIONS WORLDWIDE, CONSOLIDATES ITS PRESENCE IN THE GERMAN MARKET, BRINGING THE TOTAL NUMBER OF STORES MANAGED IN GERMANY TO 257.

CEO FRANCO MOSCETTI: "WE HAVE, IN THIS WAY, TAKEN ANOTHER STEP ALONG OUR GROWTH PATH."

Milan, August 18th, 2015 – Today Amplifon, worldwide leader in the distribution and fitting of personalized hearing solutions, announced the purchase from a private party – through the subsidiary Amplifon Deutschland – of 30 stores spread out over five different *Länder* (regions) in northeastern Germany: Thuringia, Saxony, Saxony-Anhalt, Lower Saxony and Brandenburg.

The stores acquired, which in 2014 posted sales of slightly more than Euro 6 million, currently operate under the brands Hörgeräte Böckoff, Wilhelm Böckhoff GmbH (27 stores), Steinmeier KG (2 stores) and Steinmeier Akustik und Optik GmbH (1 store). As a result of the acquisition, which will be effective from September 1st, the total number of stores managed by Amplifon in the German market will rise to 257.

"With the agreement signed in the past few days, we are taking another significant step to further pursue the Group's growth strategy, consolidating our market share in Germany, one of the most important markets in the world", Franco Moscetti, Amplifon's Chief Executive Officer commented. "We are convinced that we will be able to develop ample synergies with the existing network, including in terms of marketing, and to further increase profitability in the German market".

The transaction, which will be financed using Amplifon's available liquidity, will not have a significant impact on the Company's financial position. The acquisition is value-accretive in terms of EV/Ebitda and calls for a total investment of approximately Euro 10 million.

Amplifon, listed on the STAR segment and the FTSE Italia Mid Cap Index of the Milan Stock Exchange, is the worldwide leader in the distribution and customization of hearing aids and related services.
