*Turin, 24 August 2015.* ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 17 August to 21 August 2015 included, n. 51,500 of the Company's ordinary shares (equal to 0.06% of the share capital), at an average price of € 12.2630 per share for a total amount of about € 631.5 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,705,800 own shares (5.35% of the share capital) of which n. 4,684,300 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
