ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 7 September to 11 September 2015 included, n. 27,000 of the Company's ordinary shares (equal to 0.03% of the share capital), at an average price of € 12.2369 per share for a total amount of about € 330.4 thousands.
