ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 14 September to 18 September 2015 included, n. 73,000 of the Company's ordinary shares (equal to 0.08% of the share capital), at an average price of € 11.8017 per share for a total amount of about € 861.5 thousands.
