## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 21 September 2015 and 25 September 2015 acquired no. 7,000 treasury shares at an average unit price of € 11.7609 per share, for a total amount of € 82,325.98.
