Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 5 October 2015 and 9 October 2015 acquired no. 5,275 treasury shares at an average unit price of € 11.7980 per share, for a total amount of € 62,234.21.
