## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 14 December 2015 and 18 December 2015 acquired no. 3,704 treasury shares at an average unit price of € 11.5682 per share, for a total amount of € 42,848.78.
