Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 4 January 2016 and 8 January 2016 acquired no. 4,248 treasury shares at an average unit price of € 11.2949 per share, for a total amount of € 47,980.87.
