## ENEL GREEN POWER: 2016 CALENDAR OF CORPORATE EVENTS

**Rome, January 22<sup>nd</sup>, 2016** – As a reference for the financial community, Enel Green Power S.p.A. announces its financial calendar for 2016.

First, following the completion of the partial non-proportional spin-off of Enel Green Power S.p.A. to Enel S.p.A. that is currently under way, the company's shares will cease trading on the Mercato Telematico Azionario ("MTA") organised and operated by Borsa Italiana S.p.A. and on the Spanish continuous electronic trading system *Sistema de Interconexión Bursátil* (SIBE). The transaction is scheduled to close, subject to the conditions established by law and the parties, by the end of the first quarter of 2016. The following calendar should be considered valid as long as Enel Green Power shares continue to be traded on the MTA in Italy and on the SIBE in Spain.

The 2016 dates on which the accounts will be examined by the Board of Directors of Enel Green Power S.p.A. are as follows:

In addition, as part of the presentation of the update to the Enel Group's Strategic Plan, the guidelines of the corporate strategies of the Enel Green Power Group will also be presented.

The Shareholders' Meeting called to approve the statutory financial statements of Enel Green Power S.p.A. at December 31<sup>st</sup>, 2015, and the allocation of net income, is scheduled to be held in a single call on May 17<sup>th</sup>, 2016.

As for the calendar of dividend payments in 2016, the dividend accruing on 2015 is scheduled to be paid on May 25<sup>th</sup>, 2016, with an "ex dividend" date of May 23<sup>rd</sup>, 2016 and a record date of May 24<sup>th</sup>, 2016.

The market will be notified in due time of any changes to the above arrangements.
