*Turin, 1 February 2016.* ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 26 January to 29 January 2016 included, n. 32,500 of the Company's ordinary shares (equal to 0.04% of the share capital), at an average price of € 9.9364 per share for a total amount of about € 322.9 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,975,950 own shares (5.65% of the share capital) of which n. 4,954,450 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
