Since the start of the programme, WIIT has bought N° 140,360 ordinary shares (equal to 0.50% of the share capital equal to Eur 2,802,066.00), for a total value of EUR 3,999,603.37.

Following the purchases made so far, WIIT holds a total of N° 1,378,523 own shares, equal to approximately 4.92% of the share capital equal to Eur 2,802,066.00.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
