## FILED SLATES FOR THE APPOINTMENT OF THE BOARD OF STATUTORY AUDITORS AND A PROPOSAL ON THE APPOINTMENT OF A DIRECTOR EX ART. 2386, I PAR., C.C.

Bologna, 8<sup>th</sup> April 2022 – Datalogic S.p.A. (Borsa Italiana S.p.A.: DAL), a company listed on Euronext Star Milan of the Italian Stock Exchange managed and organized by Borsa Italiana S.p.A. (the “Company”), global leader in the automatic data capture and process automation markets, announces that, with reference to the Shareholders’ meeting of the Company called on April 29<sup>th</sup> 2022 (“Shareholders’ Meeting”), the following two slates of candidates for the appointment of the Board of Statutory Auditors of the Company have been filed, within the relevant legal terms:

It should be noted that the group of shareholders that submitted the slate no. 2 declared the absence of any connection and/or significant relationship with shareholders that also jointly hold a controlling interest or a relative majority interest, pursuant to art. 148 of the Consolidated Law on Finance and art. 144-quinquies of the Issuers' Regulation.

With reference to the item 3 of the Shareholders' Meeting Agenda, related to the appointment of a Director pursuant to the art. 2386, first paragraph, of the civil code, the group of shareholders that submitted the slate no. 2 for the appointment of the Board of Statutory Auditors of the Company has filed also a proposal for the appointment of Ms. Maria Grazia Filippini as member of the Board of Directors of the Company. Ms. Filippini was coopted from the Board of Directors on November 11, 2021, following the resignation, communicated on October 29, 2021, of Mr. Roberto Pisa. Also the Board of Directors of the Company has proposed to appoint Ms. Maria Grazia Filippini member of the Boars, as mentioned in the Explanatory Report of the Board on the agenda of the shareholders' meeting.
