ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 1 February to 5 February 2016 included, n. 78,000 of the Company's ordinary shares (equal to 0.09% of the share capital), at an average price of € 9.8794 per share for a total amount of about € 770.6 thousands.
