Gefran S.p.A. preliminary consolidated results to 31 December 2015

Provaglio d'Iseo (BS), 11 February 2016 – The Board of Directors of GEFRAN S.p.A. met today under the chairmanship of Ennio Franceschetti at the Company's headquarters in Provaglio d'Iseo (BS).

On the agenda was the examination by the directors of the Group's preliminary consolidated results, reported below.

Revenues came in at EUR 115.3 million for the year ending 31 December 2015, down 11% compared with 2014, in line with what anticipated in November. The result was affected by the performance of the Chinese market, where Gefran recorded a decrease of 38%.

The EBITDA margin was 4.9%: Group profitability was impacted by the trend in revenues.

Net debt came out at EUR 24.9 million, an improvement of approximately EUR 2.7 million compared with 31 December 2014, when it was EUR 27.6 million.

The agreement to sell the photovoltaic business to Indian group Rishabh is being finalised.

Finally, the Group continues to implement restructuring measures, and the activities provided for by regulations governing the redundancy procedure in Gefran S.p.A.: the company has announced 65 redundancies.

Approval of the draft financial statements and consolidated financial statements is set for 10 March 2016.

The **Gefran Group** operates directly on the main international markets, through sales branches in Italy, France, Germany, Switzerland, the UK, Belgium, Spain, Turkey, the US, Brazil, China, Singapore, India, and through manufacturing branches also in Germany, Switzerland, Brazil, the US and China.

The **Gefran Group** currently has more than 850 employees.

The key factors behind **Gefran**'s success are specialist know-how, design and production flexibility, capacity for innovation and the quality of its processes and products. Absolute control of process technology and application knowhow also enable **Gefran** to produce instruments and integrated systems for specific applications in a variety of industrial sectors, including the processing of plastics, the food and pharmaceutical industries, packaging and die casting machines.
