ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 8 February to 12 February 2016 included, n. 87,000 of the Company's ordinary shares (equal to 0.10% of the share capital), at an average price of € 9.3653 per share for a total amount of about € 814.8 thousands.
