ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 15 February to 19 February 2016 included, n. 79,000 of the Company's ordinary shares (equal to 0.09% of the share capital), at an average price of € 9.9319 per share for a total amount of about € 784.6 thousands.
