## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 22 February 2016 and 26 February 2016 acquired no. 4,240 treasury shares at an average unit price of € 10.5743 per share, for a total amount of € 44,834.98.
