### **AMPLIFON: Update on the share buy-back program**

**Milan, February 29<sup>th</sup>, 2016** – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 21<sup>st</sup>, 2015, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period February 22<sup>nd</sup> – 24<sup>th</sup> 2016 a total of 18,000 ordinary Amplifon S.p.A. shares, equivalent to 0.008% of the share capital, at an average unit price of Euro 7.252 per share, for a total consideration of Euro 130,540.80.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 2,178,417 shares.

As of February, 26<sup>th</sup> 2016, Amplifon owned n. 6,426,583 of its shares, corresponding to 2.850% of the Company's share capital.
