**Milan, March 21**<sup>st</sup>, **2016** – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 21<sup>st</sup>, 2015, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period March 14<sup>th</sup> – 18<sup>th</sup> 2016 a total of 30,000 ordinary Amplifon S.p.A. shares, equivalent to 0.013% of the share capital, at an average unit price of Euro 7.401 per share, for a total consideration of Euro 222,038.40.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 2,189,417 shares.

As of March,18<sup>th</sup> 2016, Amplifon owned n. 6,487,583 of its shares, corresponding to 2.877% of the Company's share capital.
