Rome, March 29th, 2016 – Enel S.p.A. (“**Enel**”) and Enel Green Power S.p.A. (“**EGP**”) hereby announce that the deed of demerger executed on March 25th, 2016, concerning the partial non-proportional demerger of EGP in favour of Enel, has been registered today with the Companies’ Register of Rome.
