AMPLIFON: Update on the share buy-back program

Milan, March 30th, 2016 – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 21st, 2015, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period March 21st – 24th 2016 a total of 24,000 ordinary Amplifon S.p.A. shares, equivalent to 0.011% of the share capital, at an average unit price of Euro 7.710 per share, for a total consideration of Euro 185,035.20.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 2,194,417 shares.

As of March, 24th 2016, Amplifon owned n. 6,506,583 of its shares, corresponding to 2.885% of the Company's share capital.
