## Finmeccanica signs a contract to supply 28 Eurofighter Typhoon to Kuwait following an agreement between the government of the State of Kuwait and the government of the Republic of Italy

- Moretti: "An outstanding industrial success for Finmeccanica and Italy"
- The largest contract ever signed by Finmeccanica
- Supports established expertise and skilled jobs in Italy and other partner nations
- The Eurofighter is a key asset for the security and defence of national airspace

Rome, 05 April 2016 – The Kuwait Ministry of Defence and Finmeccanica, which leads commercial activities in Kuwait on behalf of the Eurofighter consortium, today signed a contract for the supply of 28 Eurofighter Typhoon aircraft, to be produced in Italy. The contract, part of an intergovernmental agreement between the two countries, was signed in the presence of the Italian Defence Minister Roberta Pinotti and her Kuwaiti counterpart, H.E. SHAIKH Gen. Khaled Al Jarrah Al Sabah.

The contract signed by Finmeccanica includes logistics, operational support and the training of flight crews and ground personnel, which will be carried out in cooperation with the Italian Air Force. The contract also provides for the upgrade of ground-based infrastructure in Kuwait which will be used for Typhoon operations.

The Eurofighter Typhoon for Kuwait, which will be provided in its most advanced configuration, will be equipped with the cutting-edge new E-Scan radar (Electronically Scanned array radar). The radar is developed by the European EuroRADAR consortium which is led by Finmeccanica.

The contract with Kuwait was signed following a thorough flight and technical evaluation of a number of competing aircraft in the same category. It is part of a wide-ranging partnership between the Italian Ministry of Defence and the Kuwait Ministry of Defence, which will continue to strengthen cooperation between the two nations and other European members of the Eurofighter consortium (the UK, Germany and Spain).

"This is Finmeccanica's largest ever commercial achievement", said Mauro Moretti, Finmeccanica CEO and General Manager. "It is an outstanding industrial success with significant benefits, not only for our company and the other Eurofighter consortium partners, but also for the entire Italian aerospace industry. The contract will support expertise and skilled jobs at Italian small and medium-sized security and defence companies."

**Finmeccanica** is among the top ten global players in Aerospace, Defence and Security and Italy's main industrial company. As a single entity from January 2016, organised into business Divisions (Helicopters; Aircraft; Aero-structures; Airborne & Space Systems; Land & Naval Defence Electronics; Defence Systems; Security & Information Systems), Finmeccanica operates in the most competitive international markets by leveraging its areas of technology and product leadership. Since entering into service in 2003, over 470 Eurofighters have been delivered to the Air Forces of six countries. The aircraft is currently in service with 22 operational units, and the whole fleet has logged more than 330,000 flight hours with very high efficiency and operational availability.

The Eurofighter Typhoon is the most advanced new generation multi-role/swing-role combat aircraft currently available on the world market. Eight customers have already ordered the Eurofighter Typhoon. With 599 aircraft ordered, Eurofighter Typhoon is currently the largest military procurement programme in Europe. Its high technology strengthens the position of the European aerospace industry in the international market. The programme secures more than 100,000 jobs in 400 companies and about 20,000 jobs in Italy in 200 companies. Eurofighter Jagdflugzeug GmbH manages the programme on behalf of the Eurofighter Partner Companies Finmeccanica, BAE Systems and Airbus Defence and Space in Germany and Spain, which are the most important aviation and aerospace companies in Europe.
