ASTM S.p.A. announces that, in the contest of the authorization to purchase and dispose treasury shares approved by the Shareholders' Meeting of 15 April 2015, acquired, in the period from 11 April to 15 April 2016 included, n. 32,000 of the Company's ordinary shares (equal to 0.04% of the share capital), at an average price of € 10.5009 per share for a total amount of about € 336 thousands.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 5,282,450 own shares (6% of the share capital) of which n. 5,260,950 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
