## REVISED FINANCIAL REPORTING CALENDAR

Geox S.p.A. has announced the revision of its financial calendar, following recent legislative changes (Italian legislative decree no. 25 of 2016) removing the obligation to publish interim financial reports for the first and third quarters (implementing the EU Transparency Directive).

From May 12<sup>th</sup>, 2016, Geox S.p.A., on an ongoing, voluntary basis, will nonetheless continue to publish press releases with information on sales revenues for the first and third quarters together with order book performance for the following six-month period, which will be commented on and discussed in the usual conference call with analysts and investors. No changes are to be made to the publication of half year and full year results.

The Board of Directors of Geox S.p.A. is in favour of this EU directive being implemented and believes that Geox's business performance will be better represented by reporting on quarterly revenues and full half year results, considering the strong seasonal fluctuations that are typical of this sector and which can only be properly interpreted on a six-monthly basis.

Geox will issue the press release with details of its revenue performance for the first quarter of 2016 on May 12<sup>th</sup>, 2016 at approximately 5.30 p.m. (CET). A conference call with the management will be held at the same time.
