AMPLIFON: Update on the share buy-back program

Milan, May 23rd, 2016 – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18th, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period May 16th - 20th 2016 a total of 40,000 ordinary Amplifon S.p.A. shares, equivalent to 0.018% of the share capital, at an average unit price of Euro 8.484 per share, for a total consideration of Euro 339,360.00.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 2,254,417 shares.

As of May, 20th 2016, Amplifon owned n. 6,604,583 of its shares, corresponding to 2.929% of the Company's share capital.
