Roma, 17 giugno 2016 – Leonardo-Finmeccanica ha annunciato oggi, insieme al suo distributore giapponese Kaigai Corporation, che Kagoshima International Aviation ha ordinato il suo secondo elicottero AgustaWestland GrandNew per svolgere missioni di elisoccorso (EMS, Emergency Medical Service) nella Prefettura di Kagoshima. Il velivolo entrerà in servizio nell'autunno del 2016.

Quest'ultimo ordine è parte del programma denominato Doctor Heli finalizzato alla realizzazione di una moderna rete di servizi di eliambulanza per tutte le prefetture del Giappone. Il GrandNew di Kagoshima International Aviation dispone di una configurazione di missione dedicata con una cabina in grado di ospitare una barella e quattro posti per il personale medico. Il velivolo è inoltre dotato di un serbatoio ausiliario per estendere ulteriormente il raggio d'azione.

L'ordine espande ulteriormente la presenza di elicotteri GrandNew per compiti di pubblica utilità nel mercato giapponese e conferma il crescente successo della serie di elicotteri AW109 in Giappone, con più di 80 velivoli venduti per molteplici missioni tra cui eliambulanza, pubblica sicurezza, trasporto corporate e supporto ad attività editoriali e alle riprese televisive.

Kagoshima International Aviation orders another Grandnew EMS Helicopter

- Aircraft to enter service in the fall of 2016, expanding the presence of the GrandNew in Japan for public services
- More than 80 AW109 series helicopters sold to Japanese customers to date
- Over 150 helicopters of various types sold by Leonardo-Finmeccanica in Japan

Rome, 17 June 2016 – Leonardo-Finmeccanica announced today with its distributor Kaigai Corporation of Japan that Kagoshima International Aviation has placed an order for a second AgustaWestland GrandNew light twin engine helicopter to perform emergency medical service (EMS) missions in Kagoshima Prefecture. The aircraft is expected to enter service in the fall of 2016.

This latest purchase is part of the Doctor Heli system programme which is intended to provide modern airborne EMS coverage to all prefectures in Japan. Kagoshima International Aviation's GrandNew features a dedicated EMS configuration with a cabin layout able to accommodate one litter plus four medical attendants. The aircraft is also fitted with an auxiliary fuel tank to extend its range and endurance.

The order further expands the presence of the GrandNew in the Japanese public service market and continues the growing success of the GrandNew and AgustaWestland's range of AW109 aircraft in Japan, with more than 80 aircraft sold to date to perform a range of missions including EMS, law enforcement, executive/private transport and electronic newsgathering.

Through its Regional Business Headquarters, opened in Tokyo in 2008, Leonardo Helicopters has been supporting its growing business in Japan. Over 150 helicopters of various types have been sold in Japan to date for a wide range of commercial and government roles.
