With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 20 June 2016 and 24 June 2016 acquired no. 5,176 treasury shares at an average unit price of € 9.2272 per share, for a total amount of €47,760.06.
