With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 4 July 2016 and 8 July 2016 acquired no. 1,157 treasury shares at an average unit price of € 9.3069 per share, for a total amount of €10,768.11.
