## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 18 July 2016 and 22 July 2016 acquired no. 305 treasury shares at an average unit price of € 9.1695 per share, for a total amount of €2,796.70.
