## UPDATE ON THE SHARE BUY-BACK PROGRAM

---

*Milan, August 8<sup>th</sup> 2016* - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 18<sup>th</sup>, 2016, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period August 1<sup>st</sup> - 5<sup>th</sup> 2016 a total of 40,000 ordinary Amplifon S.p.A. shares, equivalent to 0.018% of the share capital, at an average unit price of Euro 8.842 per share, for a total consideration of Euro 353,663.76.

In reference to the same resolution, the Company has used treasury shares to service the first cycle of the Performance Stock Grant Plan 2011-2020 for a total of n. 3,067,167 shares.

As of August, 5<sup>th</sup> 2016, Amplifon owned n. 6,509,833 of its shares, corresponding to 2.882% of the Company's share capital.
