Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015 and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 29 August 2016 and 2 September 2016 acquired no. 1,646 treasury shares at an average unit price of € 9.2291 per share, for a total amount of € 15,191.11.
