3. Report on the adequacy of the share swap ratio under art. 2501-sexies, civil code, issued by the auditing firm Ernst & Young S.p.A.;
4. Financial situation under art. 2501-quarter, paragraph 2, civil code, represented by Banca Popolare di Milano's financial statements at 31 December 2015;
